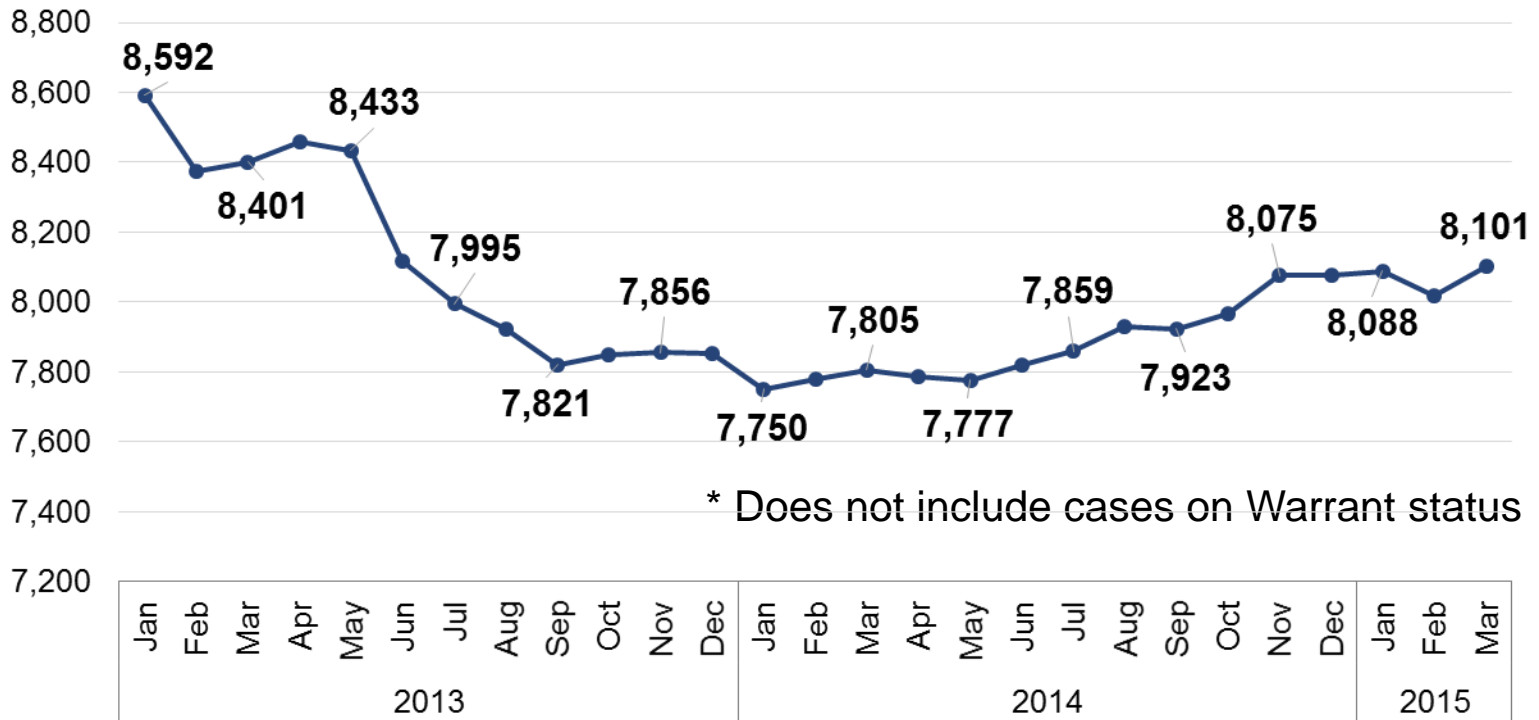

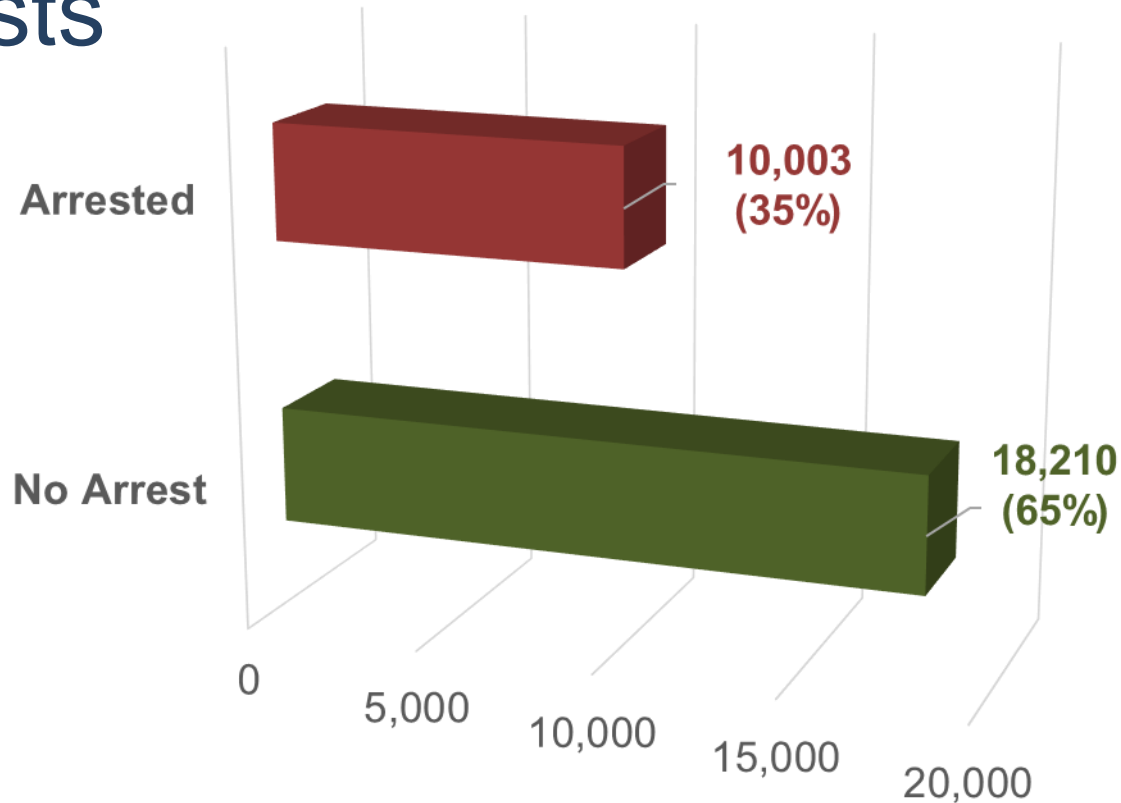
PRCS Terminations

Arrests

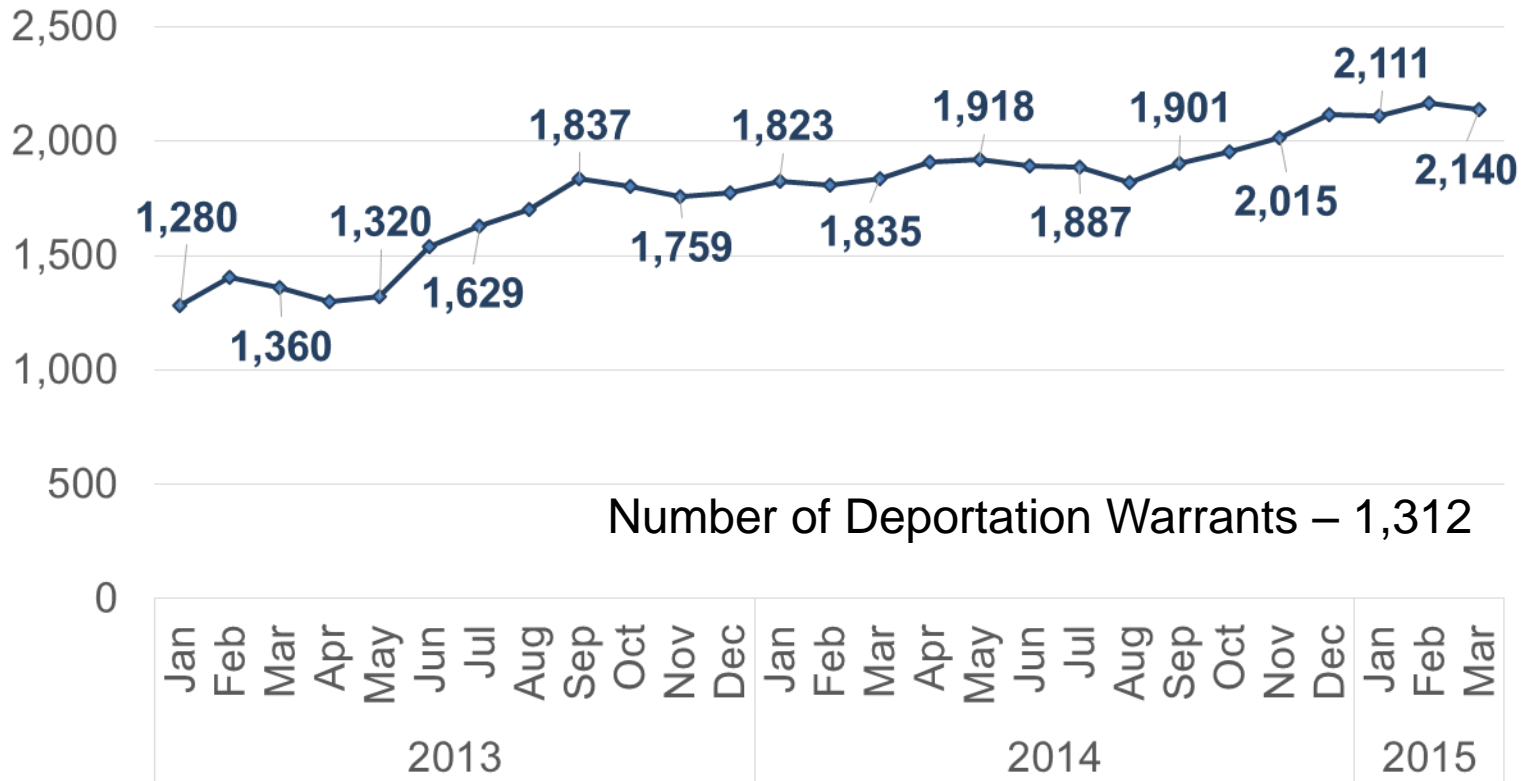
42% - Overall rate of those who returned to custody as a result of a flash incarceration, New Arrest for a misdemeanor/felony, or Revocation.

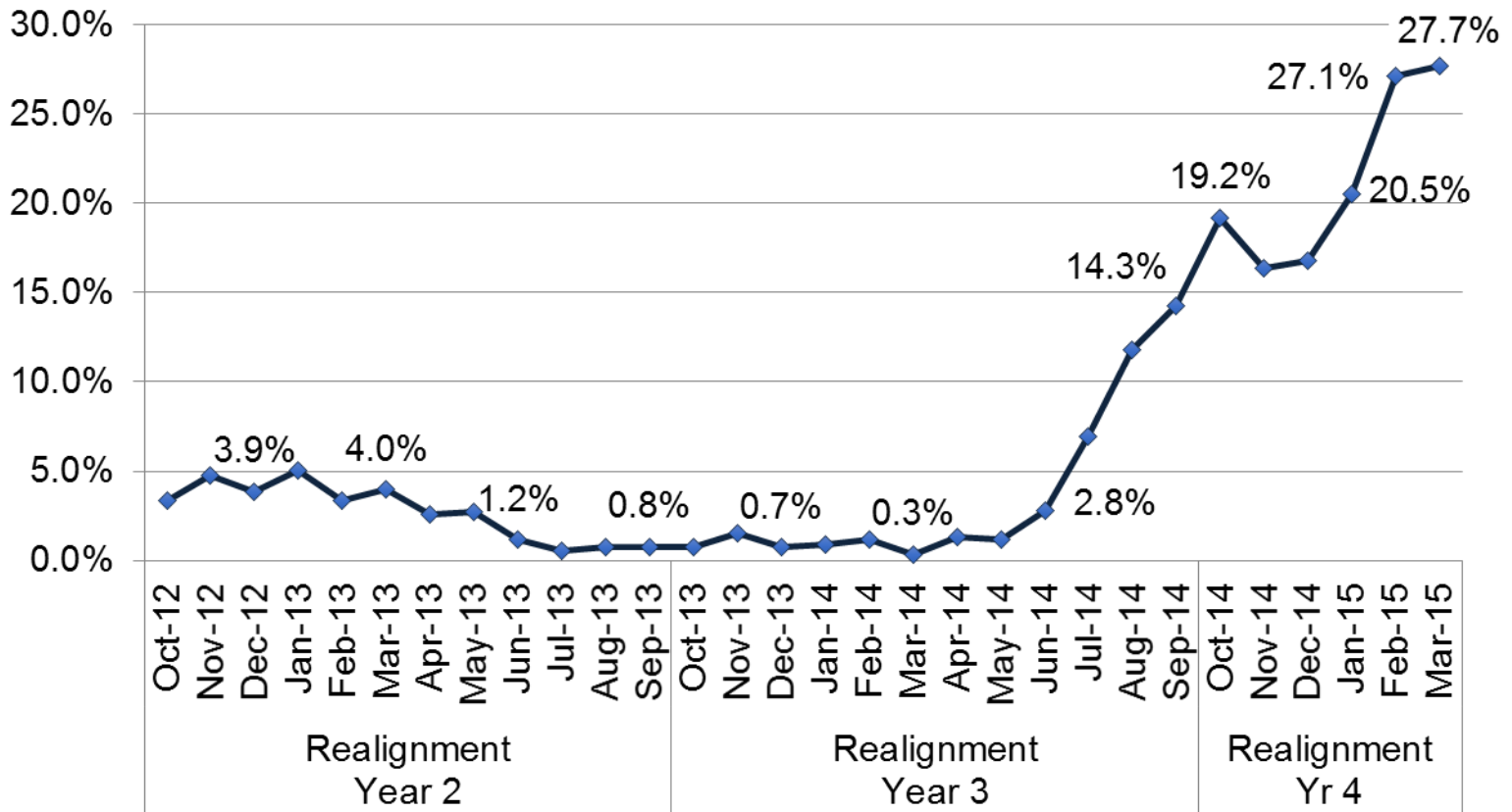


Split Sentences

- District Attorney's Office commitment to the increased utilization of Split Sentences June 2014.
- Passage of Assembly Bill 1468: All 1170(h) sentences are presumed to be Split Sentences unless the court deem otherwise, in the interest of justice. Effective January 1, 2015.

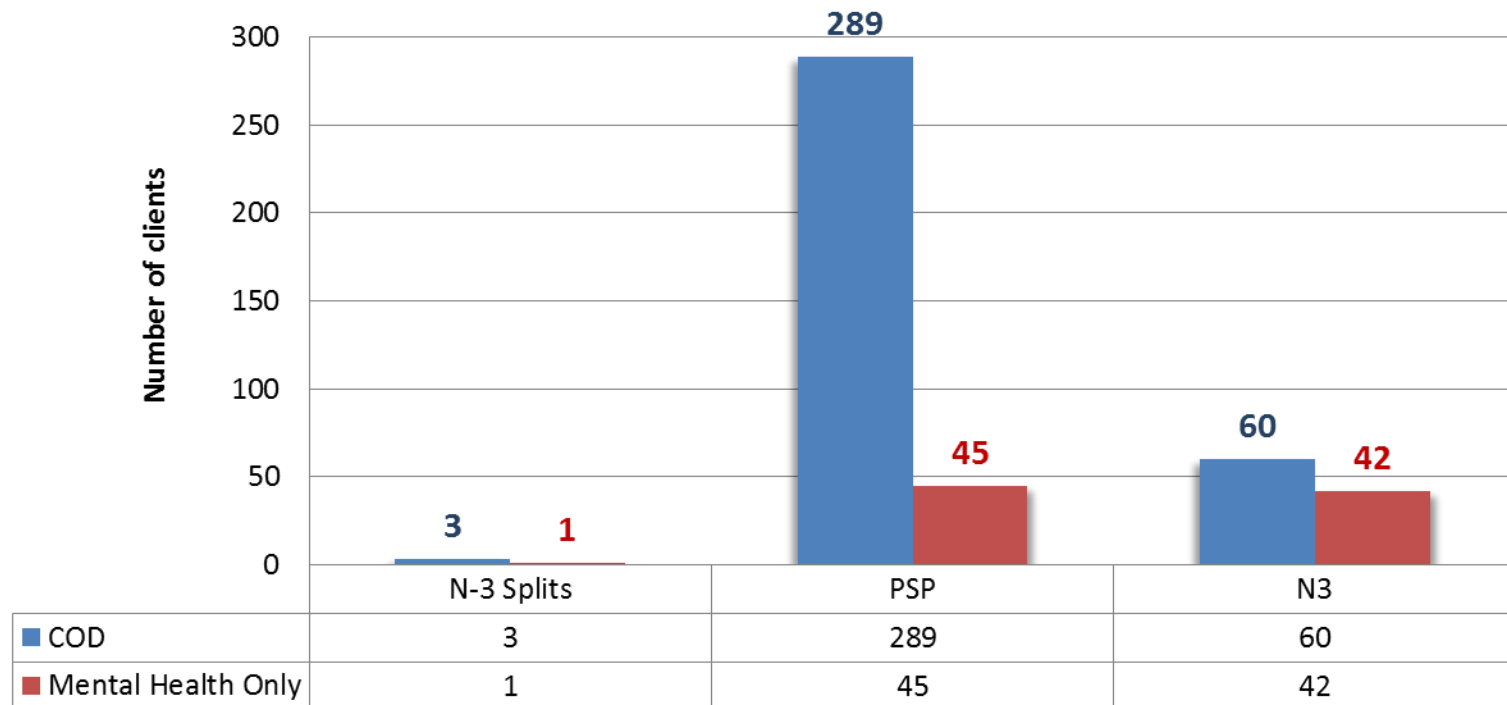


AB 109 Quarterly Report

- Though the PRCS population has slightly decreased, the overall number of new PSPs accessing treatment services from the Department of Mental Health (DMH) has not declined since Proposition 47 took effect.
- DMH has seen an increase in new admissions to treatment actually increased from November 2014 to January 2015 as compared to the same three-month period the year before.
- DMH identified 87 PSPs who were receiving services prior to being resentenced. Of those, only two (2 percent) remained in treatment following the termination of their PRCS case.

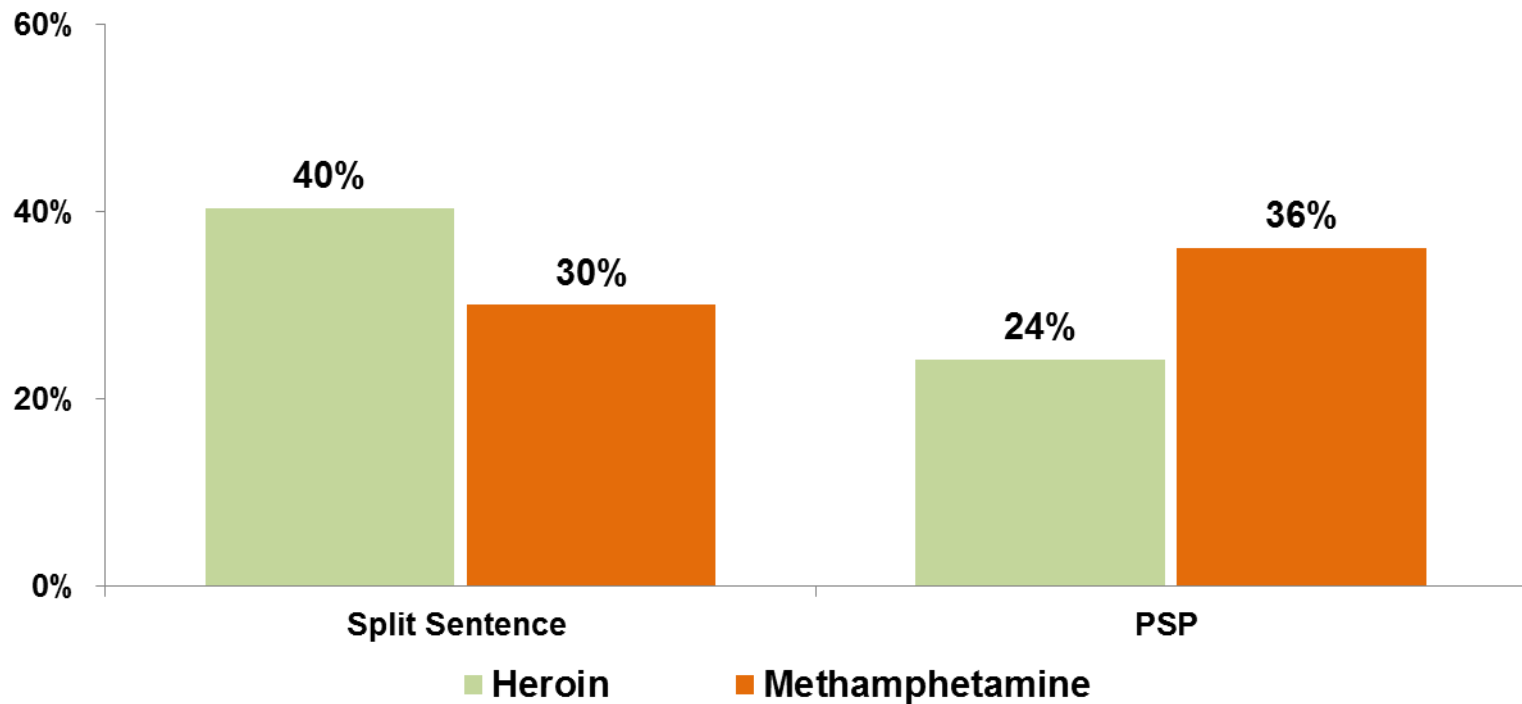


Proposition 47: Impact on Substance Abuse Treatment Services

- Impact not yet fully evident
 - SUD admissions unchanged, Nov 2014 – Jan 2015
- Resentenced participants may elect to continue with SUD treatment services
- DPH utilizing non-AB 109 funding sources
- Funding constraints may limit access to SUD services in the future with growth of Prop. 47 resentenced population

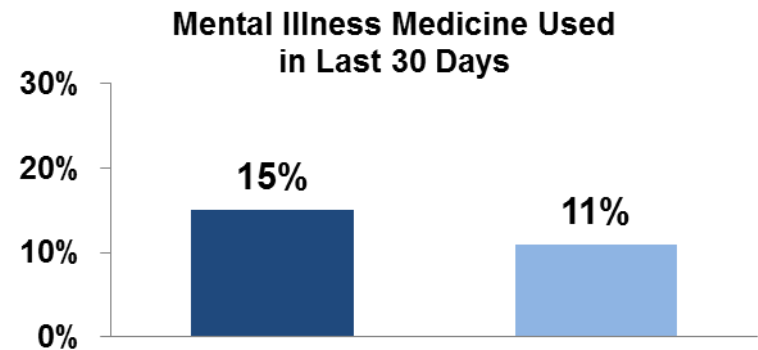
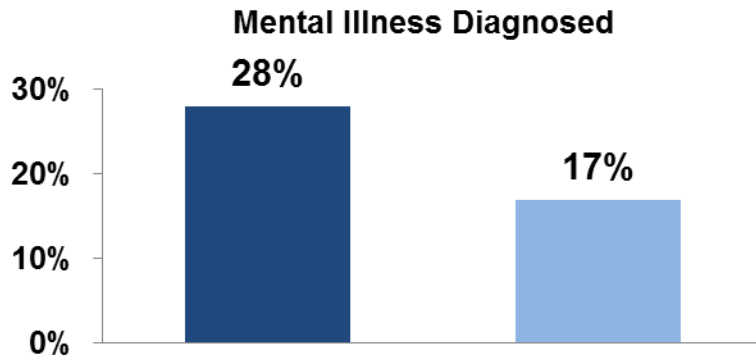
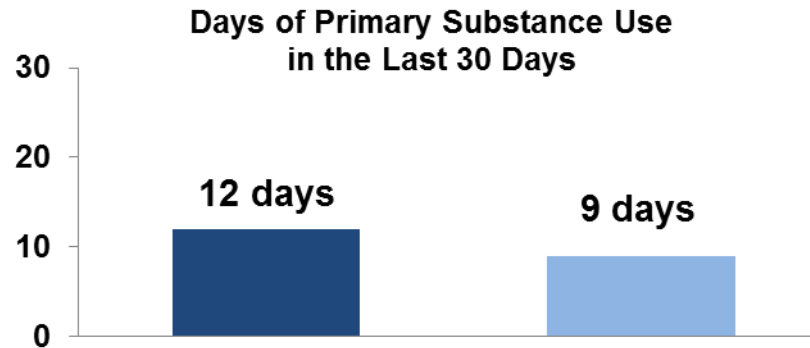
Comparing SUD Treatment Needs between Split Sentence and Post-Release Supervised Persons (PSP) Populations

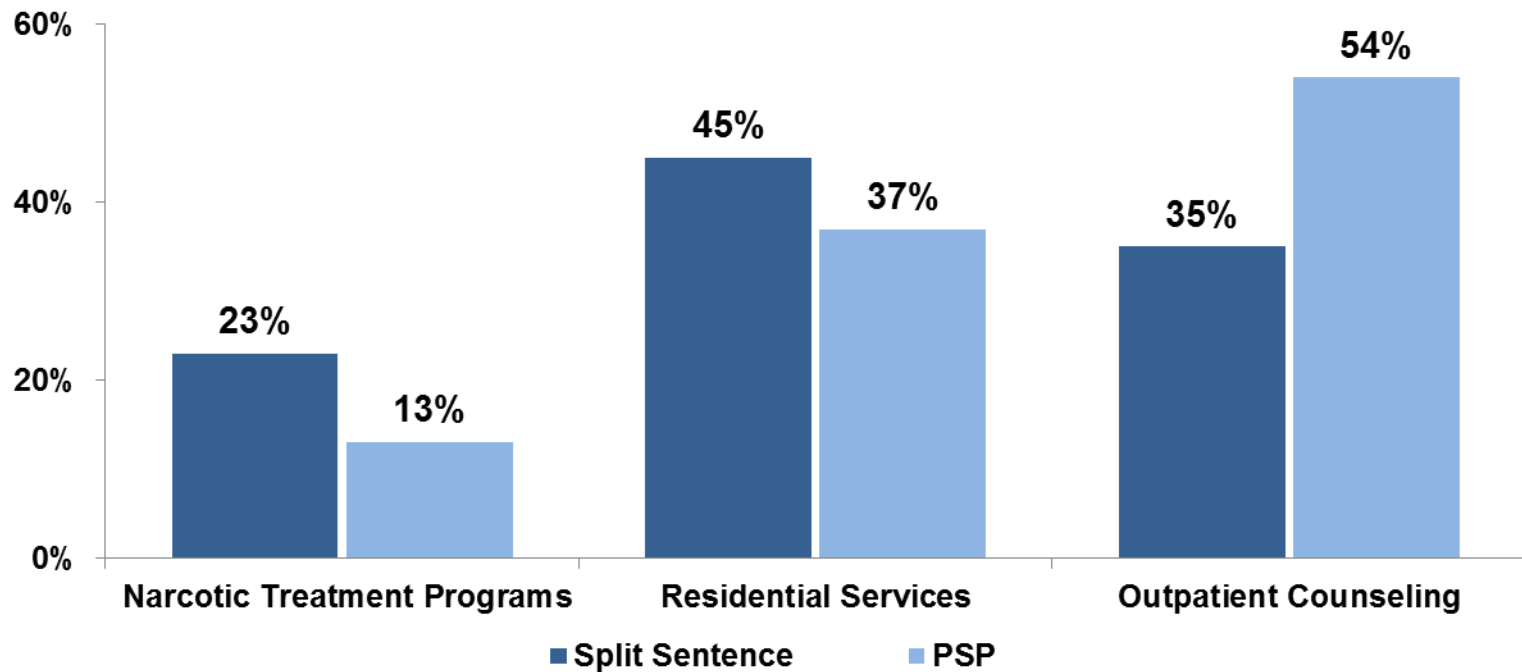
Days of Primary Substance Use and Mental Health Problems at Admission

Summary: Characteristics of Split Sentences compared to PSPs

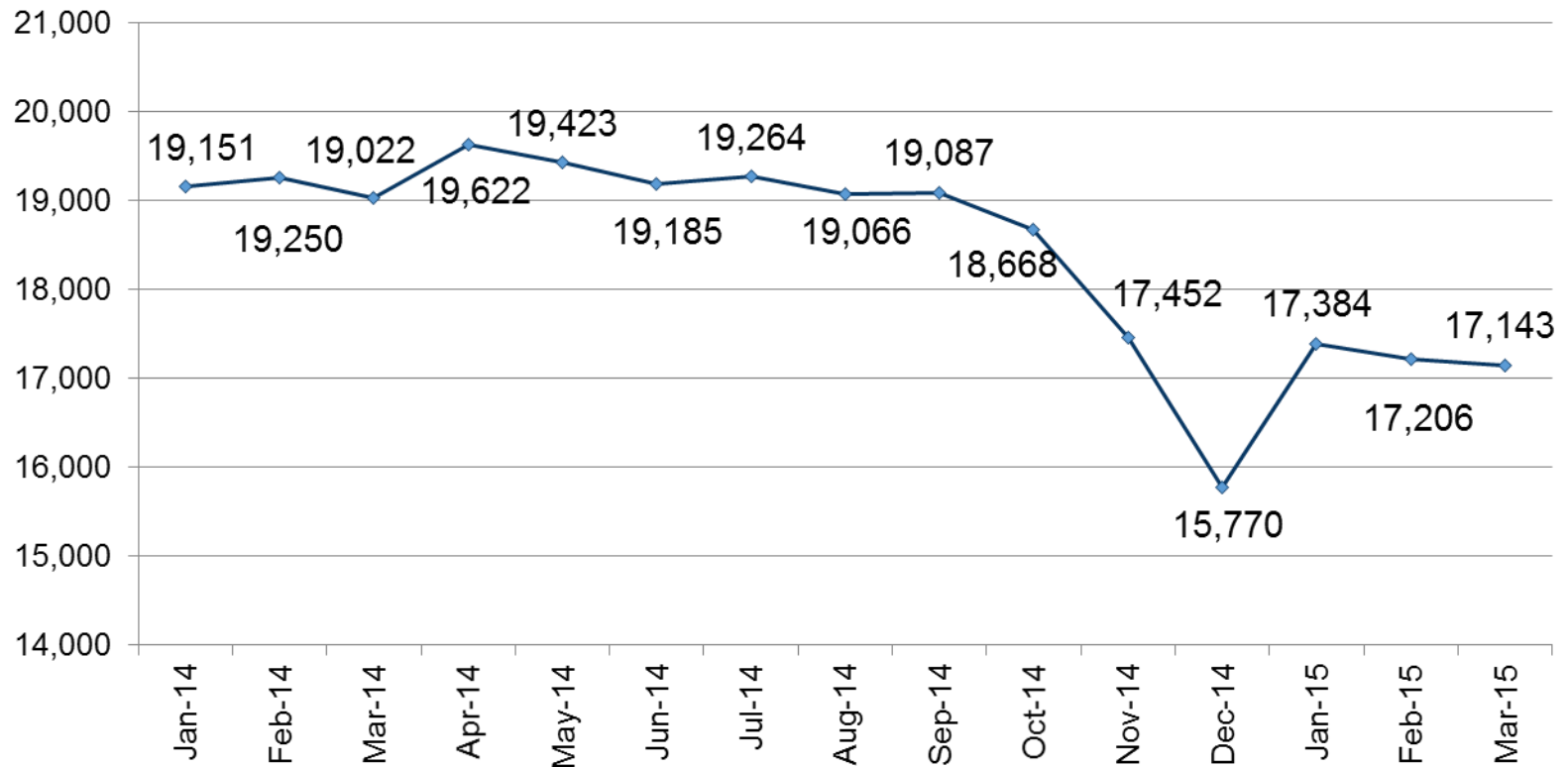
- Heroin as primary drug of choice
- Higher frequency of primary substance use
- Higher percent of mental illness history and mental illness medication usage
- Higher percent of admissions into Narcotic Treatment Programs and Residential Services.

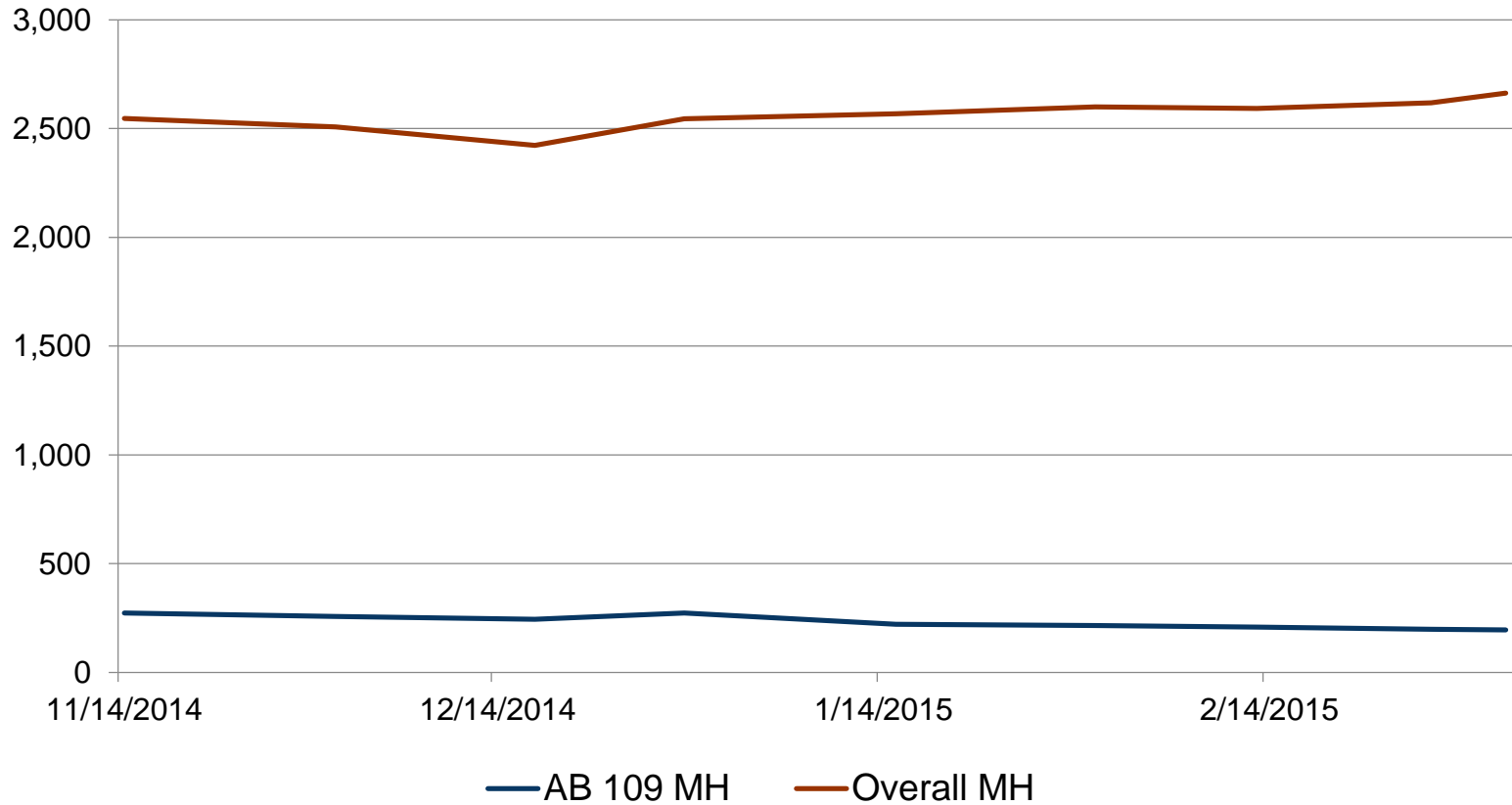


Jail System's Average Daily Population (Last Day of the Month)



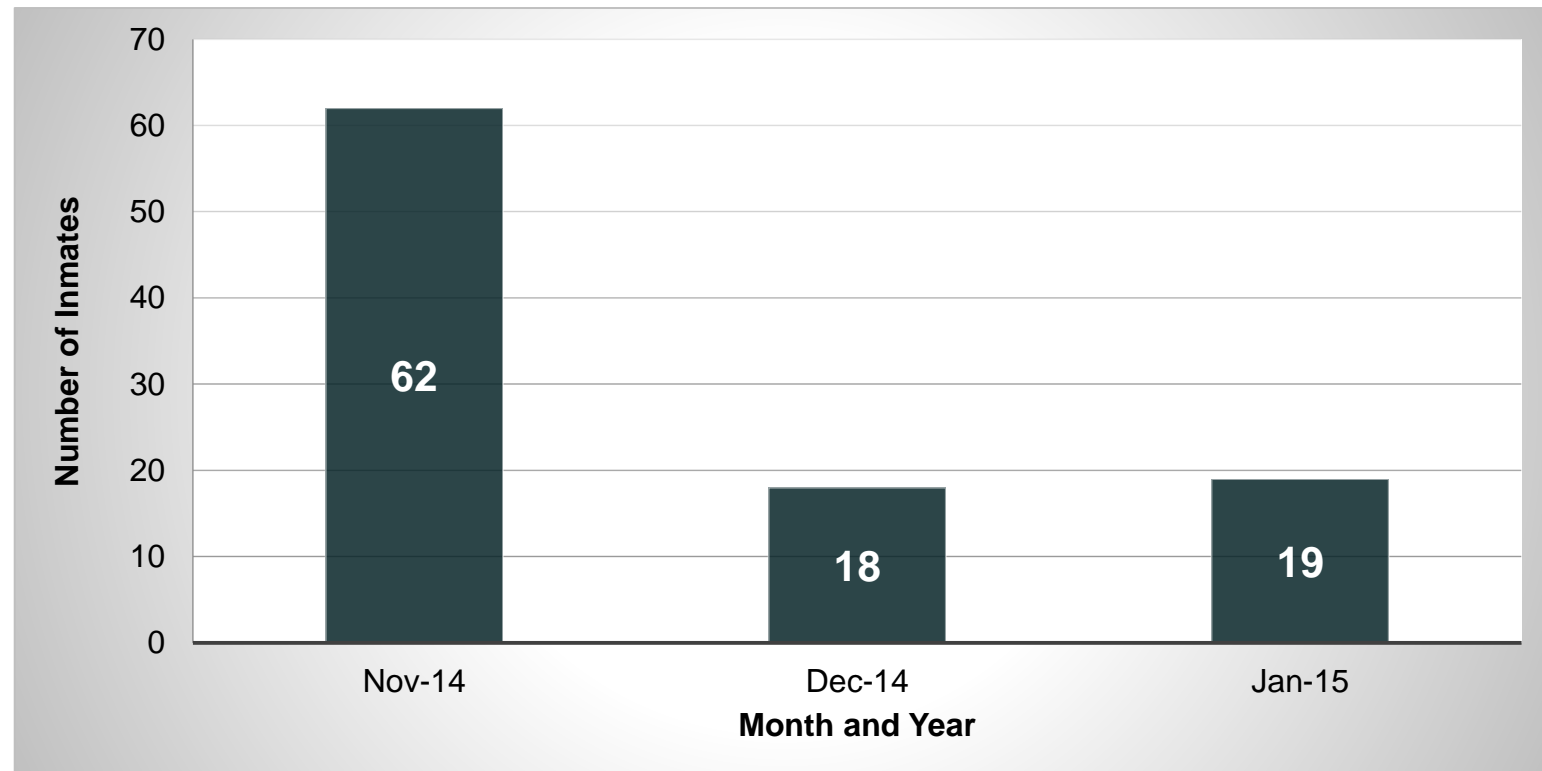


Jail Mental Health Population
